1- The Public Key Infrastructure ‘PKI’ & e-certification :

We propose to set up a partnership with the Asian structure for experience share in matter of :

- legal and organizational scope,
- Structuring the e-signature system inside the Arab countries and between them, and how to develop the relevant infrastructure,
- Capacity-building
- Possibility of ensuring common recognition between signature authorities in Japan and the Arab region.

2- Electronic Commerce :

- Launching an Arab-Japanese virtual market on the Net
- Participate in tenders and purchasing published in Arab countries and Japan.

3- Adopting international standards in the field of ICT quality certification :

- Partnership project with Japanese certification authorities such as the ‘Japan Quality Assurance Organization’ (JQA)
- Japanese technical assistance to develop an Arab certification program

4- Developing technoparks and providing assistance to startups:

- Experience share in :
 - management of technological poles,
 - Assistance to startups specialized in ICT
 - Setting up empowerment mechanisms for the emergence of startups with high added-value and a high capacity for innovation and creation.

5- Arab capacity building in the field of ICT :

- ICT Skill certification is considered as the most important development resulting from globalization

6- Boosting joint investment mechanisms in ICT

- Creation of a Fund boosting ICT joint investment through the participation in the economic companies capitals created within the scope of partnership between companies from both sides.

7- Boosting scientific exchange and partnership in the field of scientific research and technological innovation :

- Exchange of students between Arab universities and research centers to benefit from the programme set up by the Japanese government and known as ‘G30’, and which aims at hosting 300000 foreign students to study in Japanese universities, and register copyrights in the field of ICT.

8- Boosting partnership in the field of ‘Mobile TV’ :

- Seek cooperation with Japanese companies advanced in this field, such as : “DoCoMo” and “Hitachi” within the scope of the Arab project “Introducing the Mobile TV in the Arab Region” which aims at :
 - 1- Introducing Mobile TV in the Arab region with regards to the social and economic reality,
 - 2- The business models of mobile TV and determining the relationship between the different stakeholders,
 - 3- The legal and legislative scope adapted to the development of this new market.
